REGISTRATION OF FINANCIAL AND OTHER INTERESTS

(Statutory Instrument: 2012 No. 1464)

Give notice that I have set out below under the appropriate headings, my interests which I am required to declare under The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and the Council's Code of Conduct and I have put "none" where I have no such interests under any heading.

I understand that the Localism Act 2011 requires that I am required to regard as a Disclosable Pecuniary Interest (as set out in sections 1 - 7) an interest of my spouse or civil partner, a person with whom I am living as husband or wife or a person with whom I am living as if it were civil partners as my own.

(i) DISCLOSABLE PECUNIARY INTERESTS

1. EMPLOYMENT

In this section you must give details of any employment, office, trade, profession or vocation carried on for profit or gain.

2. SPONSORSHIP

In this section you must give details of the name of any person, other than a local authority, including any political party, which has made a payment to you in respect of your election or any expenses incurred by you in carrying out your duties as a councillor.

This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

(You do not need to declare the amounts of any payments received under this section; only the name of the person or body making them).

3. SECURITIES

In this section you must detail the name of any body which has a place of business or land in the Council's area, and in which you have:-

- i) a beneficial interest in a class of securities of that body which exceeds the nominal value of £25,000.00, or one 100th of the total issued shared capital of that body; or
- iii) If the share capital of that body is of more than one class, the total nominal value of the shares in any class in which the relevant person has a beneficial interest exceeds one 100th of the total issued share capital of that class.

(The nominal value per share is that shown on the share certificate. Mutually owned building societies need not be included under this section, only those which have converted to public limited companies and where share ownership exceeds that stated above)
